PRECAUTIONARY STATEMENTS

FIRST AID

GENERAL INFORMATION

90/10 Surfactant is a general purpose surfactant, activator for use on plants to maximize the effectiveness of insecticides, fungicides, herbicides, acaricides, defoliants and desiccants. The surface-active agents in 90/10 Surfactant are designed to improve wetting and spreading of agricultural sprays on leaf, stem or insect surfaces. It also contains a defoamer that helps suppress spray tank foaming. 90/10 Surfactant is suitable for use where the pesticide label recommends surfactants, spreader or wetter.

DIRECTIONS FOR USE

REFER TO PESTICIDE LABEL FOR SPECIFIC CROP USE AND APPLICATION RATES.

0.5 to 4 pints per 100 gallons of spray solution. Use enough 90/10 Surfactant to achieve good wetting, spreading and surface coverage without excessive run-off.

NOT FOR AQUATIC USE.

Note: The above use recommendations are considered to be adequate for most uses. Some pesticides, however, may require higher or lower rates for optimum effect Follow the pesticide label directions when this occurs.

MIXING INSTRUCTIONS

Prior to any pesticide application all spray mixing and application equipment must be cleaned. Carefully observe all cleaning directions on the pesticide label. Fill spray tank one-half full with water and begin agitation. Add pesticides as directed by labeling or in the following sequence:

1. Dry flowables or water dispersible
2. Wettable powders
3. Flowables granules
4. Solutions
5. Emulsifiable concentrates
6. Add Farm General 90/10 Surfactant last and continue agitation.
